This year we recognized the retirement of our dedicated and remarkable Executive Director.

Earl J. Reisdorff, MD, stepped down as Executive Director on December 31, 2024. He held his position for nearly 15 years, serving as the third Executive Director of ABEM.

#### **Transforming Initial Certification**

In 2024, we announced the new Certifying Exam will launch in 2026. ABEM's Board, staff, and volunteers saw great progress in the development of the exam and administration logistics. Two types, Clinical Care Cases and Communication and Procedure Cases, and eight cases within the two types, were selected and publicly posted. Key references to show the evidence basis for the case types were identified and shared, and sample videos for each case type were created and published.

#### Continuing Certification

Since the launch of MyEMCert modules in 2021, ABEM continues to hear positive feedback. More than 23,000 MyEMCert modules were completed in 2024, which have helped physicians maintain their certification and stay current in practice. ABEM also remains committed to partnering with CME providers to offer CME credit for modules and other ABEM activities. Be sure to select the CME option when registering! All CME fees go directly to our CME providers, the American Academy of Emergency Medicine and the American College of Emergency Physicians.

#### Growth of the Specialty

There were 47,524 physicians certified in Emergency Medicine by ABEM at the end of 2024; a 2.6% increase from the prior year.

Of all ABEM-certified physicians in Emergency Medicine, 97% were Emergency Medicine residency-trained.

Subspecialty certification numbers also increased, both in absolute numbers and as well as the proportion of ABEM-certified physicians who are subspecialty certified. In 2024, there were 4,773 ABEM-issued subspecialty certificates, which is 9.2% of all ABEM Emergency Medicine physicians.

#### **New Credential Opportunities**

<u>Health Care Administration, Leadership, and</u> <u>Management (HALM)</u> subspecialty certification was launched in 2024. The first examination was administered November 11-28, 2024. There were 150 physician leaders who passed the inaugural examination and are now board certified in HALM. Candidates were offered the opportunity to take the examination at a secure testing center or using Pearson VUE's online proctoring system. The overall passing rate was 75% for all test takers. For those physicians who were eligible through the practice pathway, the pass rate was 74%, and for physicians who were eligible through the training pathway, the pass rate was 81%. Emergency Behavioral Health (EBH) Focused Practice Designation (FPD) is coming soon. ABEM continues to bring forward ideas that resonate with our communities. U.S. emergency departments are stressed with admissions related to the mental health crisis and those who lack access to EBH care. ABEM and the American Board of Psychiatry and Neurology have worked together on this initiative. The FPD was approved in 2025, and a certification will be administered in 2026. This can greatly impact our communities.

Disaster Medicine subspecialty is under development! This is another key issue affecting communities during times of crisis. After lengthy discussions with the American Board of Medical Specialties (ABMS) and the Accreditation Council for Graduate Medical Education, ABEM received authority to apply to ABMS as the "administrative" board for a subspecialty in Disaster Medicine.

#### Final Reflections

Throughout 2024, we made great strides. We all have tremendous responsibility and are passionate about the work we do; it matters. Our volunteers continue to stay on top of key trends such as emergency technologies, health care policies, and behavioral and mental health. As Emergency Medicine changes, we are recognizing the pain points within the structures and working to maintain excellence during the unexpected. ABEM leadership, volunteers, and staff remain committed to maintaining high standards in the specialty.

ABEM will continue to make progress, collaborate with our peers, support you, and promote the value of ABEM-certified physicians. Together we are resilient and determined to embrace the changes that are ahead. It is an honor to work with all of you.






AGE (YEARS)


Number of Diplomates by Age Training and Practice Percentages by Live Diplomates




